This Deed of partnership is made between the following

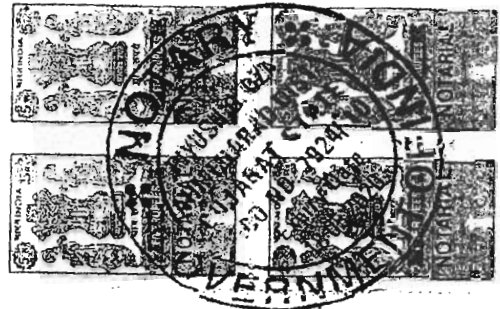

- (2) **Smt. Meenaben Kaushikbhai Joshi (PAN NO. AANPJ4704P)** aged about 59 years, residing at 122 Vibhisha bungalows, opp. Homeopathic college, ghuma , Bopal, Ahmedabad -380058 Here in after referred to as party of the **SECOND PART**

WHEREAS the parties of the First and Second parts are desirous of starting the business of Trading activities of Food items , bakery items and cosmetics items and consumer durable all items, in the name and style of **M/S. KAUNAM CORPORATION** and hence decided to form the partnership with effect from 21<sup>ST</sup> May 2019.

NOW THIS DEED WITNESSTH THE TERMS & CONDITIONS OF THE PARTNERSHIP AS UNDER.

- (1) The name of the partnership firm shall be **M/S. KAUNAM CORPROATION** and / or any other name or names to which the partners may mutually agree upon.
- (2) The principal place of the partnership firm shall be at 122 Vibhisha bungalows, opp. Homeopathic college, ghuma , Bopal, Ahmedabad -380058
- (3) The principal business of the partnership firm shall be Trading activities of Food items , bakery items and cosmetics items and consumer durable all items or any other business or which partners may mutually agree upon.
- (4) This partnership firm shall come into existence from 21<sup>ST</sup> May 2019. and its first accounting year shall end on 31<sup>ST</sup> March 2020.

(5) The duration of the partnership firm shall be "AT WILL"

(6) All the partners have agreed to look after the business of the partnership by devoting their time and attention to the business of partnership and they will be entitled to draw yearly remuneration as under:

The total remuneration payable to the working partners shall be worked out as under:

In case of loss or book profit upto Rs.300000/-For the year Rs.150000/- or 90% of the book profit whichever is higher

On the book profit exceeding Rs. 300000/- 60% of the excess over Rs.300000/-

Explanation: For the purpose of this clause the expression "Book Profit" shall mean the "Book Profits as defined in section 40(b) of the I.T. Act, 1961. or any statutory modification or reenactment thereof for the time being in force."

The partners shall be entitled to increase or reduce the above remuneration and may agree to pay remuneration to other partner or other partner or partners. The parties hereto may also agree to revise the mode of calculating the above remuneration and decide to pay salary and grant the benefit of house rent allowance, rent free quarters, accident and / or life insurance policies. Provident fund, gratuity, bonds, commission on sales / gross receipts and / or other benefits to the above and / or the other partner or partners either on monthly or yearly basis as they may mutually agree upon

The partners shall be entitled to modify the above terms relating to remuneration, interest etc. payable to the partners by executing a supplementary deed and any such deed when executed shall have effect unless otherwise provided from the

first day of the accounting period in which such supplementary deed is executed and the same shall form part of this deed of partnership.

7) The funds required for the purpose of the partnership business shall be contributed or arranged by the partners in such manner as may be mutually agreed upon. Interest at the rate of 12% or such other rate as may be prescribed under section 40(b) (iv) of the income tax Act, 1961. or any other applicable provision as may be in force for the income tax assessment of the partnership firm for the relevant accounting period shall be payable by partnership on the amount standing to the credit of the capital and/or current or loan account or the accounts of the partners. If there is any debit balance in the account of any partner, interest at the above rate shall be payable by him.

(8) the net profit/loss of the partnership business as per account maintained by the partners after deduction of all expenses relating to manufacturing and/or trading activities of the partnership including rent, salaries and other establishment expenses as well as interest and remuneration payable to the partners in accordance with this deed of partnership or any supplementary deed as may be executed by the partners shall be divided and distributed amongst the partners in the following proportion.

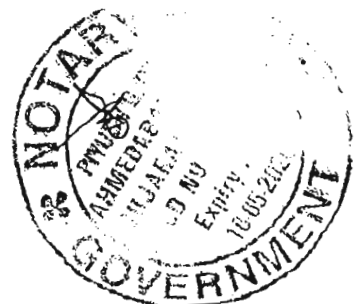


(13) in case any dispute between the partners, the same shall be settled in view of the law of Arbitration Act in force.
